Info: This show is a benefit for Spring Gulch, and the funds from this benefit and tack sale will go toward maintaining and improving the cross-country course at Spring Gulch. Helmets and boots with heels required; also, vest & medical armband for cross-country required; Otherwise, dress is informal; Dressage tests may be read. **Bring your own bib for numbers for xc.**

Fees: Office fees are included in the following:

1. Combined Test: dressage test of your choice and cross-country round at the level = **\$65**;
2. Cross-country schooling rounds (at end of the show) = **\$25 per round**; **THE HORSE MAY ONLY GO CROSS-COUNTRY TWICE** (i.e. once at combined test and one schooling xc round). You may sign up for schooling rounds that day.
3. Dressage Tests: Dressage tests of your choice = **\$25 per test**. As many dressage tests as you want! Please duplicate this page if you need to list additional tests

COMBINED TEST: \$65 (Check one level) XC refusals do not count, but XC is timed.
